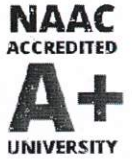

- All scholarship will be applicable for the complete duration of the course, unless stated otherwise in the admission letter.
- All scholarship only for Indian Students & applicable only on Academic fee.
- Student can avail any **one category** of the above listed applicable scholarship only.

VGU Alumni: - Any student who holds a qualification degree from VGU and is a member of the VGU alumni association.

VGU Student: - Any individual who is currently enrolled at VGU, Jaipur.

VGU Employee: - Any individual who is Employee of VGU/VIT/VTS (Jaipur/Nagaur/Bikaner)/SKIP (Bikaner). Only staff members who have completed 2 years in the above listed institutes shall be eligible.

Co-curricular Excellence: - Any candidate having distinction in activities other than academics like sports, theater, dance etc from a recognized authority.

❖ Academic Fee Payment Options

1. Self-financed – Students may pay the academic fee at the time of admission for the first year and later annually or semester-wise.

2. Financial Assistance-

2.1. Bank Loans – To facilitate bank loan, CDOE-VGU registrar office shall provide admission letter and fee schedule on request of the student. The Proforma for the same available on CDOE-VGU website.

2.2. No Cost EMI
The University in partnership with NBFC provides the students with the option for flexible payments, Auto-Debit facility, etc. Students are provided with 8 EMI option on complete annual fees.

The procedure to apply for the loan facility is as follows: -

Step: -1 Visit the Pay through EMI link on website

Step: -2 Click on apply Now and fill the Basic details, Academic details and KYC details

Step: -3 Every student is eligible who is enrolled with CDOE-VGU

Step: -4 All KYC details should be provided without which the application may be rejected

Step: -5 Accept loan EMI agreement digitally

Step: -6 On acceptance of the application the fee will be disbursed in the University account post verification of all the documents and signing of the Digital agreement

Note: -

All fees paid through an NBFC or bank loan are the complete responsibility of the student. Any failure to pay fees on time through an NBFC or bank loan will result in a late fee penalty for the time period missed, as per the notice issued by CDOE-VGU.

Student would abide by admission guidelines with related policies issued by the University from time to time.
